Long-term care

Do you require 24-hour personal and nursing care on a short-term or long-term basis? We can provide financial support to qualifying Veterans for the cost of this care.

About this program

All health systems in Canada provide some level of long-term care support in provincially licensed or regulated facilities.

Financial support from Veterans Affairs Canada may be available when you have been admitted to 24-hour care in a community bed (available to any provincial resident) or contract bed (only available to Second World War or Korean War Veterans).

The assessment process and admission to long-term care facilities is managed by your provincial, regional, or local health authority. Please contact the agency responsible for long-term care in your province or territory:

Do you qualify?

If you have been admitted to a long-term care facility, you may qualify for and should apply for financial assistance if you served in the Canadian Armed Forces and have:

- a low income,
- a service-related disability, or
- a health need for long-term care.

How to apply

Before you apply

Before you apply for financial assistance from Veterans Affairs Canada, you must first be admitted to a long-term care facility.

Apply online

If you are registered for My VAC Account, you can submit your application for this benefit online. If you aren't registered, you can <u>register now</u>.

Mail or in person

Download the <u>application package</u> (VAC1503APe). Then, drop it off at a <u>VAC office</u>. You can also mail your completed form directly to the address listed on the form.

The staff at any <u>VAC office</u> can assist you, or call us at 1-866-522-2122.

Note for legal representatives: Include a copy of the document that shows you to be the legal representative (e.g. Power of Attorney). If you have previously provided this, you do not need to send it again.

Related programs

<u>Treatment Benefits</u> - Coverage for medical and health related services.

<u>Veterans Independence Program</u> - Payments for home and health care services that you need to remain independent at home.

War Veterans Allowance - Monthly payments if you have a low household income.

Frequently asked questions

What is the maximum a Veteran must pay toward their long-term care accommodation costs?

Effective October 1, 2018, the maximum accommodation and meals monthly amount paid by a Veteran is \$1,039.48. Any supplementary charges such as the costs of semi-private or private rooms are not part of this calculation.

Do some Veterans pay less than the maximum amount?

Veterans who are admitted to care as a direct result of a condition for which they are in receipt of a disability benefit are not required to pay toward their long-term care. Also, Veterans may have a reduced contribution if they are married or have a lower income.

NVOC Presidents Mr Randy Stowell Report on the "Veterans Consultation Assembly" 16 Nov 2019

Myself and Ted Bransfield attended a meeting hosted by Dominion Command, Royal Canadian Legion at Legion House, Ottawa.

The meeting had a gathering of Veteran Organizations – almost twenty... [Ourselves, ANAVETS, UN Peacekeepers, Maritime Air and others]. The round table was asked to seek common issues for the new Veterans Minister – to be appointed 20 Nov.

Issues that I raised for NVOC:our members continue to advocate for Veterans long term home care – with their families; we have members concerned about a recognized "Volunteer Service Medal" [recognition for military service under the 12 year CD line]; and Caregiver Recognition – access is difficult – for men and women -and denial is rejection.

There were two presentations.

- (1) Housing Initiatives for Homeless Veterans. There are between 3000 and 5000 Veterans who are homeless in Canada. Some are living rough every night. [My Comment- No Veteran ever imagined that they would be homeless. To end homelessness you need homes].
 - "Veterans House" is an Ottawa effort construction has started in Sept move in

Remembrance Day 2020. A Multifaith housing initiative. 40 unit homes for veterans who are homeless.

- Will have programs to help veterans deal with addictions and physical/mental health. 400 square feet Not a transition home they can stay until they feel able to move away. They can not have a "live in" companion. [My Comment is that the Veteran will develop relationships reconnect with family and move out for better things. Wehad Barrack Wardens for the quarters sheet exchange and discipline now we have Mental Health workers!]
- The Legion funds mental health at this home [The Legion "Leave the Streets Behind" is a very positive effort]. Funding is interesting. VAC can NOT fund "bricks and mortar". Veterans are not a Municipal or Provincial priority for homeless veterans. Homeless Veterans can not have facilities funded by the Feds. Anecdote: The Executive Director of the Multifaith Housing Initiative told us that the early meetings with Canada Lands about Rockcliffe wanted a Statue to remind of past military days...She suggested a statue that had windows doors and space for fourty veterans. This has happened. There was considerable "Not in My Back Yard" opposition to having homeless Veterans have a home. Her story of how this was thwarted is interesting and inspiring.

VETERANS OMBUDSMAN

The Veterans Ombudsman spoke to us. Craig Dalton. A real spark of energy and focus.

They do NOT advocate – they assist and inform and they address veterans complaints within a very narrow legal mandate.

He reports to the Minister VAC.

My observations:

• The VAC "Eco-system" needs a hard look at credibility and trust.

What Veterans tell them:

- Unfair process [they get 1500 to 2000 complaints a year]
- Unfair Outcomes
- Unfair Treatment [turnaround times]

The Ombudsman impressed me – he knows veteran issues can be a "Hot Button". He spoke of how we have transitioned from "Pension for Life" to the "New Veterans Charter" to the "Pension for Life". No doubt that there is a problem for some veterans about fair treatment financially..

- Areas of Focus 2019 –2020 for him is to define what veterans "outcomes" are [not sure what that means] and Families . Families are to evaluate the impact of VAC programs/services on veterans families . [My Comment is that the family was never mentioned a few years ago. This is progress.]
- Women Veterans are a concern and gaps for programs and services for them are to be studied and corrected.

Veteran "Appeals" for disability claims is a silly process today – Tribunals versus Mediations and presumptive adjudication is a consideration.....

World War II Métis Veteran Recognition

Good Day,

In the last couple of months the Métis Veterans of Canada have received recognition for our World War II Veterans that did not receive all the benefits of other non Aboriginal Veterans. With this recognition came an official apology from the Federal Government and a cash award to all living World War II Veterans.

Yesterday I attended the first meeting for the Métis World War II Recognition Legacy Fund round table. The building of the award and management of the Legacy Fund was discussed. As per the agreement as laid out by the Federal Government. All living World War II Métis Veterans will receive a message of Official Apology from the Federal government along with a cheque for \$20,000. If the Métis World War II Veteran has passed within the last three years (From June 13, 2019) the award will then goto the Spouse. If the Spouse has passed it will then be paid to the children of the Veteran. If there are no children, then the award will be put back into the Legacy Fund.

The remainder of the Legacy fund will then be managed by a Committee Trust Board for the purposes of supporting Métis Veteran Commemorative initiatives that promote awareness and appreciation of Métis Veteran's sacrifices and contributions to the Métis people as well as the general Canadian public.

The reason I am writing to you is we cannot possibly reach all communities and we know for sure that there are other veterans out there that have not identified themselves. We are planning to have consultations with families and Veterans but right now our main focus to find any more living WWII Veterans. So I am requesting your Service Officers do a check of their veterans within the RCL membership. If you have any living Métis World War II Veterans to communicate that back to me so we can arrange to get them their apology and award.

I will be glad to answer any questions you have. I thank you in advance for helping us connect with eligible Métis Veterans.
